## SAM Call for Delegate Assembly Positions and Resolutions 2016 sent to Membership 1-18-16

School Administrators of Montana (SAM) is calling for resolutions on legislative or advocacy issues that members want to bring before the Delegate Assembly (scheduled for June 16-17, 2016 in Helena) and the full Membership at MCEL (scheduled for October 19-21, 2016 in Billings) for consideration. Please submit resolutions to the SAM office for consideration by **Friday, April 29, 2016**. The process was designed to allow SAM member Affiliates time to discuss proposals for resolutions at the Caucus meetings on the afternoon of June 16, prior to the Delegate Assembly on June 17.

Here are some suggestions if you are considering a resolution for submission to assist SAM, the Delegates and the full membership:

- State the action you are calling on SAM to address
- If it is not readily apparent from the wording of the resolution, provide any citations to legal statutes or rules that the resolution is proposing to amend (if you know)
- Provide some background information or rationale that explains your perspective on why the resolution should be considered by Delegate Assembly and the Membership
- Send the Resolution request via email to Kirk Miller, SAM Executive Director at <a href="mailto:samkm@sammt.org">samkm@sammt.org</a> by Friday, April 29, 2016 so it can be prepared for the Delegate Assembly Caucus scheduled for the afternoon of June 16.
